Election Notification No. GCT.05/2021 **dated 18.12.2021**

The preliminary list of candidates contesting in the election to the Board of Directors of Gurudeva Charitable Trust whose nominations are valid was published on 14.12.2021. The time for withdrawal if any, of the nominations expired at 5 pm on 17.12.2021. One candidate has withdrawn his nomination submitted earlier.

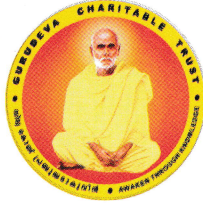
Accordingly, the final list of candidates with valid nominations contesting for election to the Board of Directors 2021-2024 is published herewith.

The Number of candidates in the final list under Class/Category-B is 23 (Twenty Three) which is the number of Directors required to be





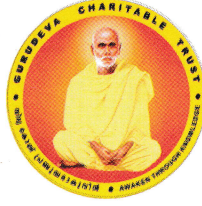

electd. Accordingly, there will be no polling for Class/Category -B and all the 23 (Twenty Three) candidates under Class/Category -B trustees as per the list appended will be declared as elected at the time of publication of the result on 24.12.2021. At the same time the number of candidates in the final list under Class/Category-C is 7 (Seven) & the number of candidates in the final list under Class/Category-D is 4 (Four), which is more than the number of Directors required to be elected from Class/Category-C & Class/ Category D.

Therefore, polling through Secret Ballot will be conducted in Kochi, Dubai, Abu Dhabi and Muscat for electing the 6 (Six) members of Directors under Class/Category-C trustees & 3 (Three) members of Directors under Class/Category-D trustees in terms of Election Notification No.1 dated 29.11.2021 on Friday 24th December 2021 from 10 am to 12 noon (IST). One trustee member can vote only for one candidate. Ballot Paper polled with more than one vote will be treated as invalid. Voting by proxy is permitted through a trustee member of the same Class/Category. A trustee member can act as a proxy of one or more trustee members belonging to his Class/Category. However, Postal vote will not be permitted.

After the polling, the candidates who get a minimum of 10 (ten) votes under Class/Category-C & a minimum of 50 (Fifty) votes under Class/Category-D will be declared elected in accordance with Article 8(a).

Venue will be SNIMS Office in Kochi and Excellent steel LLC, Ruwi (Al Muthna Square, Floor 2, Office No. 406) in Muscat.

It is hereby informed that the election venue of Dubai has been split into two as Dubai and Abu Dhabi taking into consideration of the present border checking between Dubai and Abu Dhabi due to Covid.
