ELECTION NOTIFICATION (Ref. No. GCT/01/ Dt. 26/10/2024)

Election to Board of Directors

As appointed by the Board of Directors of Gurudeva Charitable Trust (GCT) as Returning Officer under Article 24 to conduct the election to the Board of Directors and Executive Committee of the Trust for the years 2024 - 2027, it is decided to conduct the election as provided under Article 25 from Category/Class B, C and D Trustees in accordance with the schedule appended to this notification based on the final voters list to be published on 01.11.2024.

Election will be conducted in Kochi (SNIMS campus). Online voting facility will be available for those who are unable to visit SNIMS CAMPUS. The closing of business hours will be 5 PM. One Trustee is eligible to contest for only one post. Postal vote will not be allowed. Proxy form will be published along with next notification. Tentative schedule of election events and all other notifications/results will be published in SNIMS notice board and web site.

The number of eligible trustees from each class/category will be as follows:

B class = 114 nos., C class = 66 nos. and D class = 170 nos. The trustees are eligible to contest, propose, second and vote only within the Class/Category of membership which they belong to.

Accordingly the number of Directors to be elected from the above classes shall be as follows.

22 nos. from the B class Trustees, 6 nos. from C class Trustees, and 3 nos. from D class Trustees

A trustee can cast only one vote for any candidate in his/her class/category.

A candidate who gets 5 or more votes from the B class trustees will be declared elected as a Director.

Similarly 10 or more votes from C class trustees and 50 or more votes from D class trustees will be required to be declared elected as a Director and the results with all relevant documents will be handed over to the President after election.
