## Election Notification (No. GCT/06/2024 dated 15.11.2024)

The preliminary list of candidates contesting in the election to the Board of Directors of Gurudeva Charitable Trust whose nominations are valid was published on 09.11.2024. The time for withdrawal if any, of the nominations expired at 10 am on 15.11.2024. Three candidates have withdrawn the nominations that were submitted earlier.

Accordingly, the final list of candidates with valid nominations contesting for election to the Board of Directors 2024-2027 is published herewith.

The number of candidates and the number of Directors to be elected from each Class/Category are as follows;

The number of candidates in the final list under Class/Category-B is 25 (Twenty five), Class/Category-C is 7 (Seven) & Class/Category-D is 4 (Four), which are more than the number of Directors required to be elected from Class/Category-B, Class/Category-C & Class/ Category-D.

Therefore, polling through Secret Ballot will be conducted in Kochi & online, for 22 (Twenty two) members of Directors under Class/Category-B trustees, 6 (Six) members of Directors under Class/Category-C trustees & 3 (Three) members of Directors under Class/Category-D trustees in terms of Election Notification No.1 dated 26.10.2024 on Friday 22<sup>nd</sup> November 2024 from 10 am to 2 pm (IST). One trustee member can vote only for one candidate. Ballot Paper polled with more than one vote will be treated as invalid. Voting by proxy is permitted through a trustee member. A trustee member can act as a proxy of one or more trustee members. However, Postal vote will not be allowed.

After the polling, the candidates who get a minimum of 5 (five) votes under Class/Category-B, 10 (ten) votes under Class/Category-C & a minimum of 50 (Fifty) votes under Class/Category-D will be declared elected in accordance with Article 8(a).

Venue will be SNIMS Office in Kochi and online.
